

**NOTAS VIR LEIWATERAANSOEK**

- 1. Aansoeke om leiwater moet voor of op 25 Junie 2018 ingedien word.
- 2. Desondanks die feit dat ontvangs van elke aansoek om leiwater deur die Munisipaliteit erken sal word, berus die onus op die aansoeker om te bevestig dat sy/haar aansoek ontvang is deur die Munisipaliteit. Vir gerieflikheidshalwe sal 'n lys met aansoeke op 29 Junie 2018 aangebring word op die kennisgewingbord by die Munisipale Kantore vir bevestiging deur aansoekers. Telefoniese navrae kan ook gedurende hierdie tyd gerig word aan Mnr J Prins by 0282549620. **Aansoeke wat na die sperdatum ontvang word, sal nie aanvaar word nie, aangesien daar na allokasies geen wysigings gemaak kan word nie.**
- 3. Tye soos toegeken, kan nie gekanselleer of uitgeruil word nie.
- 4. Erwe wie nie 'n leibeurt vir die 2018/2019 seisoen verlang nie, sal afgesluit en geseël word.
- 5. Leiwater moet deur middel van 'n behoorlike sluis wat dig sluit (by Munisipale kanaal) geleë word op enige erf. Indien 'n sluis nie dig sluit nie, in die diskresie van die Raad, sal dit of deur die Raad op u koste herstel word, of afgesluit en geseël word.
- 6. Geen persoon mag water uit die Munisipale kanaal (al loop dit oor sy/haar erf) lei, pomp of op enige wyse belemmer of verminder, buite sy of haar toegekende ure nie, aangesien ander persone wie se wettige ure dit mag wees daardeur geraak word.
- 7. Alle versperrings en/of sluise moet buite u toegekende ure verwyder word uit die Munisipale kanaal.
- 8. Die eienaar van 'n erf moet te alle tye gedeeltes van 'n besproeiingskanaal wat oor sodanige erf loop, vry van obstruksies of struike, onkruid of plantegroei, hou.
- 9. Weens die baie probleme wat ondervind word om leiwater te beheer, is drastiese stappe ingestel en is daar 'n boete deur die Raad vasgestel vir die onwettige gebruik van leiwater.
- 10. Met u almal se samewerking en ondersteuning, vertrou ons dat hierdie bate en voorreg in ons dorp, tot almal se voordeel aangewend en benut word.

**NOTES FOR LEIWATER APPLICATIONS**

- 1. Applications for leiwater must be submitted on or before 25 June 2018.
- 2. In spite of the fact that the Municipality will acknowledge every application for leiwater, the onus rests with the applicant to ensure that the Municipality has received the application. For the convenience of the applicants, a list of applications received will be placed on the notice board at the Municipal Office on 29 June 2018, for perusal and confirmation. Telephone enquiries may also be directed to Mr J Prins at 028-2549620. **Applications received after the due date will not be considered as the allocated time-slots cannot be changed.**
- 3. Times as allocated may not be cancelled or exchanged.
- 4. Erven, which do not require a leiwater turn for 2018/2019, will be closed off and sealed.
- 5. Leiwater must flow through a sluice from the Municipal channel. Sluices must be able to close properly. If the sluice does not close properly Council will effect repairs at the cost and for the account of the owner, or close off and seal the channel.
- 6. No person may extract water from the Municipal channel (even though it may run through their property) by pumping or in any other way impeding the flow at times other than the lawful hours allocated to them, as this may deprive other consumers of water during the times they are entitled thereto.
- 7. All obstructions must be removed, outside allocated hours, from the Municipal channel.
- 8. The owner, of a property through which a leiwater channel flows, must ensure that the channel is free of vegetation, trees and other obstructions.
- 9. Due to the numerous problems which have been experienced with the controlling of leiwater, drastic steps will be taken against transgressors and Council will impose fines upon unlawfull users of leiwater, and their channels will be closed off and sealed.
- 10. With the co-operation and support of all concerned, and to the benefit of the village as a whole, this asset can be utilised and enjoyed by all users.
